All fees are subject to an annual increase due to the cost of living.

I understand that Registration fees, tuition, equipment, testing fees and private lessons are non-refundable.

Uniforms, equipment, testing fees, etc. are all additional costs and are not included in with tuition or registration unless specifically stated during enrollment specials. It is the Parent and/or Guardians responsibility to bring children younger than 14 years of age into the building and to enter the building to pick them up; we do not have monitors. We ask that students come to class dressed and remain seated or lined up in the designated area prior to their scheduled class. Parents and family members are welcome to watch classes, but must be quiet and not disturb the students or staff. Non participating siblings must be monitored and quiet at all times or may be asked to leave.
